Our work to date includes:

- We have <u>283</u> pre-enrolled students who have actively completed either on-line enrollment form or pre-registration form from grades K-5.
- We have approximately <u>25</u> bilingual teachers from the Southeast who are actively seeking employment at Dreamers Academy (<u>11</u> from Manatee seeking to follow my leadership).
- We have collaborated with <u>4</u> dual language schools in New York, Florida, and Georgia. We find that we can't 'unsee' the work and benefits of their programs, some that have been home grown...it literally brings tears to my eyes.
- We have the energy of over <u>12</u> vendors and small businesses who we are coordinating with us to bring academic success to our program.
- We have interacted with <u>2</u> universities (USF and UCF) who are seeking internship
